#### 3. Definition:

The curriculum Intent at Christ's College reflects that of our Vision. It is fully inclusive and designed to serve our community and provide opportunities for all to flourish. We recognise the context of our community and curriculum intent is to equip all students with the cultural capital to enable them to access their next steps. The curriculum cumulates to students becoming well rounded young adults that hold Christian and fundamental British values with a wide understanding of different people and different points of view.

The curriculum intent specifically for RSHE links in with the whole college vision, providing the information to acquire knowledge to help them develop healthy nurturing relationships.

### 4. Subject content, how it will be taught and who is responsible.

The content is taken from the statutory guidance, as set out by the Department for Education.

A summary of this is:

- Families
- Respectful relationships, including friendships
- Online and media
- Being safe
- Intimate and sexual relationships, including sexual health as well as what the law says
- Physical health and mental wellbeing, including Internet safety and harms, physical health and fitness, healthy eating, drugs, alcohol and tobacco, health and prevention, basic first aid and changing adolescent body
- Menstruation

Some of the content will be delivered through national curriculum subjects, such as Science, RE, ICT and PE, with others through the PHSE curriculum which includes The Story Project (Wellbeing).

Schemes of work for national curriculum subjects will be published on the College website. We will be using Church of England resources, or resources that are sympathetic to the aims of teaching in a church school, for other content. All materials will be accessible to all students, including those with special educational needs and disabilities. An opportunity will be given to parents to see the material we will be using to teach RSE before the lessons. Content will be reviewed and adapted in consultation between college and parents/carers. # 5. Details of how the subject will be monitored and evaluated

Lesson material will continue to be monitored and evaluated through our quality assurance programme of learning walks and review meetings. The DfE has made it clear that there is no right to withdraw from Relationships Education. Parents/carers do have the right to request that their child(ren) can be withdrawn from some or all sex education as part of statutory RSE. This request should be discussed with the Principal and as appropriate the child, to ensure their wishes are understood together with the nature and purpose of the curriculum.

The Principal will consider and grant the request from parents until the third term
